## Updates on the Mental Health Resolution !

At the International Convention in July, 2022, a resolution titled, "On Recognizing Mental Health Issues for Educational Staff and Promoting Support Services," was presented by the Washington State Organization. This resolution passed with overwhelming support from DKG members who were in attendance.

This resolution challenges DKG members to:

- 1) Educate themselves on mental health issues in schools,
- 2) Inform members of current mental health legislation for schools so that they can take action,
- 3) Promote destigmatization of mental illness, and
- 4) Engage in activities that demonstrate emotional support for educators.

### Exciting, late-breaking news.....

Recently introduced legislation, **HR 744** sponsored by Representative Suzanne Bonamici, (OR-1), is now in a U.S. House Subcommittee. The legislation is titled, "Supporting the Mental Health of Educators and Staff Act of 2023," and is based on the Mental Health Resolution of DKG!

DKG members are urged to ask their US Representative to co-sponsor this bi-partisan legislation.

# Your Voice Matters! Results of the October 2022 Survey of DKG Members

On October 23, 2022, the US Forum Steering Committee designed and disseminated a survey that was sent to all members of the Forum. The intent of the survey was to determine the issues that are most important for the Forum to address, in addition to mental health for educators.

The survey was sent through Facebook pages and emails to State Presidents and US Forum representatives in every state. A total of 2746 responses were received.

Respondents were asked to prioritize, from a list of current concerns, the issues they would be most interested in as the focus for the work of the US Forum.

In addition to *Mental Health for Educational Staff and Promoting Support Services*, (DKG, 2022), here are the issues, in order of priority, as selected by the respondents:

1. Safety from Gun Violence in Schools and Community
2. Poverty/Homelessness/Food Insecurity
3. Working Conditions/Recruitment and Retention of Educators and Staff
4. Censorship of Speech/Materials/Books
5. Bullying and Cyberbullying
6. Social Media and Importance to Mental Health
7. Retirement Security/Caregiving
8. Privatization of Public Education
9. Women's Health
10. Human Trafficking
11. Climate Change
12. Voting Rights
13. Racism as a Public health Crisis
14. Violence against Women

In addition to prioritizing issues, respondents were also provided an opportunity to suggest other issues of concern, and to state which Forum sponsored activities are most beneficial to them. The results of this survey will be used to guide the agenda of the US Forum Steering Committee during the current biennium.
